WELCOME

Hello

The City of Burnet, the county seat for **Burnet County**, is situated in the mid western part of the county and encompasses approximately six square miles. The population is approximately 6,000 people. The courthouse is located on the square in Burnet. There are two courthouse annexes, one on the square and the other at 1701 E. Polk (Highway 29 East).

General Information

The City of Burnet, the county seat for **Burnet County**, is situated at the northern end of the county and encompasses approximately six square miles. The population is approximately 7,000 people. The courthouse is located on the square in Burnet. The courthouse annex houses many of the county offices and is located at 1701 E. Polk (Highway 29 East).

The school district is the **Burnet Consolidated Independent School District (www.burnet.txed.net)** and consists of Burnet High School, Quest High School, Burnet Middle School, Burnet Elementary, Shady Grove Elementary R.J. Richey Campus, 6th Grade Campus and Bertram Elementary School.

The Herman Brown Free Library is located at 100 E. Washington (on the square) in Burnet. Services include weekly story hours for preschoolers, adult reading literacy and G.E.D. study programs, computers, internet access and counselors to teach the novice computer user, and a meeting room for community use.

Seton Highland Lakes is a 42-bed acute care hospital and a member of the Seton Healthcare System. Services include 24 Hour Emergency Room, Home Health Services, Hospice Services, Occupational Therapy, Physical Therapy, Cardio/Pulmonary, and Chemotherapy. Seton is located at 3201 S. Water, (Highway 281 South.)

The **Municipal Airport** is located at Kate Craddock Field at 2302 S. Water (Highway 281 South). Services include a 5,000 ft. lighted runway, paved taxi strip, Avgas and jet fuel, aircraft maintenance service and instrument landing service. Covered hangers are available for a fee. Contact Faulkner Air Service for information (512) 756-6655.

Burnet is located approximately 55 miles northwest of

Austin. Austin Bergstrom Airport is the nearest major airport.

Fort Croghan Museum and Grounds provides a glimpse of life as it was during the mid 1800's when Burnet was founded. The museum houses more than 1200 artifacts from the area. The fort grounds include log cabins, a powder house, a look-out building, a stage coach stop, a one-room school house and others. The Commemorative Air Force Museum is located at Kate Craddock Field in Burnet, Texas. The museum features military memorabilia, static displays and planes. The CAF Highland Lakes Squadron holds fly-ins throughout the year.

Parks and Recreation

Burnet offers several community parks across the city. **Hamilton Creek Park** includes paved walkways, fountains, gazebos, picnic areas and a children's play area. Hamilton Creek Park is located on Highway 29 West just past the Highway 281 junction.

Galloway Hammond Recreation Center offers a wide variety of recreational activities including two indoor swimming pools, an outdoor splash park, a large gymnasium and complete workout center. The facility also offers disc golf, ball fields, and an RV Park with three-way hookups. Call (512) 756-6180 for more information or go to www.gallowayhammond.com on the world wide web. Galloway Hammond is located at 1601 S. Water (Highway 281 South).

Delaware Springs Golf Course is a municipal golf course that is open to the public. This 18-hole championship course offers a pro shop, driving range, putting green, snack bar and dining room overlooking the number eighteen green. Haley Nelson Park is a 51-acre park located just off Highway 29 West at 301 Garden Trails Drive. The park offers soccer fields, a pavilion, an amphitheater, disc golf, hiking trails and washer pits.

Transportation

The C.A.R.T.S. program provides transportation to residents locally and to Marble Falls, Bertram, Georgetown, Round Rock, Temple and Austin. Call 1-800-456-RIDE (7433) at least 24 hours in advance to schedule a ride or to get more information.

Senior Programs

The Neighborhood Association provides a number of services to local seniors (age 60 and above) including Meals on Wheels, lunch at the neighborhood center, O.A.R.S. (respite services for caretakers of the elderly), "Friendly Visits", transportation services, and bingo. Call 756-4334 for more information about the services.

CITY UTILITIES

General

The City supplies electricity, water, sewer and garbage services to its citizens. All utilities are billed under one billing which is sent out on the last working day of the month. Payment for services are due by the 10th of the month and can be mailed to P.O. Box 1369, Burnet, Texas, 78611; can be brought to the City Municipal Offices at 1001 Buchanan Drive, Suite 4 (Highway 29 West; dropped in the drop box at City Hall; paid by bank draft; or paid online (see City Web Site on other side.)

Bills not paid by the 10th are subject to a late fee. Bills not paid by the 20th are subject to disconnection. A re-connection fee will be charged when service is reconnected. In the event of a hardship or emergency, citizens may apply for an extension (subject to annual limitations). Extension applications can be picked up at the Burnet Municipal Office or downloaded from the City's web site. Two disconnections or more may result in an increased deposit.

Bills paid with insufficient funds are subject to immediate disconnect and will be charged an NSF fee. Receipt of two or more NSF payments in one year will require customer to pay with cash or money order for future payments and may result in an increased deposit.

Information on the utilities application is considered public information unless specifically requested to be held as confidential. Confidentiality forms can be obtained at the City Municipal Office or downloaded from the internet. Information applicable to the confidentiality request are name, address and social security number only.

Reporting Problems

Call (512) 756-6093 to report problems with City utilities during business hours. To report problems after 5 p.m. in the evening, before 8 a.m. in the morning, on weekends or on City holidays call the after hours numbers.

Electric Service

The Electric Department is responsible for reading electric meters, and reporting usage to the billing department. They are also responsible for repairing electric lines and installing new electric lines across the City. Citizens must make their meters accessible to the reader. Meters should be in clear view and free of brush, debris and animals.

It is unlawful to tamper with electric meters in any way or to share electric service with other households. Every household must have their own meter. Violators will be prosecuted.

Security Lights are available for a monthly fee from the Electric Department. Contact the utility office to schedule installation.

The after hours number for electric emergencies is (830) 798-4775.

Water and Sewer

The City provides water and sewer services to the citizens of Burnet. The Water/Wastewater Department is responsible for all water and sewer issues. Report any breaks immediately by calling (830) 798-4776. City water is regulated by state regulatory agencies and mandatory guidelines are followed to assure high standards. The City uses surface water from Inks Lake.

The proper disposal of grease and other wastes is required in order to protect sewer lines, not only on City property but on personal property as well. A flyer regarding the proper disposal of grease and other wastes can be obtained by going online or from City Hall.

The after hours number for water or sewer emergencies is (830) 798-4776.

Sanitation

The City of Burnet has contracted with IESI to provide garbage services to citizens of Burnet. (See the

brochure on garbage services for additional information.) Household garbage is collected once weekly. Call the City of Burnet or refer to the Route Map (available at City Hall) or the City Services page on the web site, to determine which day your location is collected. Prohibited items include batteries, tires, hazardous materials, and liquids. Pick-ups scheduled on a holiday will be picked-up on the following work-day. Refrigerators, freezers or air conditioning units will be picked up from the curb side ONLY if tagged by a certified technician to be Freon free. Carts are provided by IESI in accordance with the service you signed up for. Standard residential service includes one 90-gallon cart per household. IESI will pick up bundled brush and tree cuttings, up to three cubic yards, (*this is about a 4 ft. tall by 4 ft. long by 4 ft. deep bundle*) along with the regular trash pickup. Any more than three cubic yards on a given pickup day will be charged at a rate of \$7.50 per cubic yard. All brush and cuttings must be bundled in no more than four foot lengths.

Customers who wish to rent a dumpster can call the Utility department at City Hall to schedule the rental. Prohibited items include batteries, tires, hazardous materials, and liquids. Roll-off boxes are scheduled by IESI by calling 1.866.282.3508.

Animal Control

The City of Burnet Code of Ordinances regulates the control of animals within the City of Burnet. The Office of Animal Control can be summoned for nuisance animals including wild animals providing they are within the city limits. You can also call the Animal Control Office to report dangerous or potentially dangerous animals, abused, neglected or unwanted animals. To report a problem animal dial 911 to have an officer dispatched or you can call the Animal Control Officer at (830) 798-3971.

Current shelter fees will be charged for the housing of your animal. Animals are housed at the Christ-Yoder Animal Shelter and Adoption Center which is operated by the Hill Country Humane Society/SPCA at Buchanan Dam. In the event your pet is picked up by Animal Control, you can contact the shelter at (512) 793-5463. The shelter is located at 9150 Highway 1431 West in Buchanan Dam. Hours are 10-2 Monday through Saturday. Animals are held for a maximum of five days. Dead animals can be disposed of by placing them in a plastic bag and putting them in your trash receptacle for pickup by the Sanitation provider.

EMERGENCY SERVICES

General

Fire/EMS and Police services are provided by the City through your tax and utility dollars.

Fire/EMS

Burnet Fire/EMS Department provides emergency and non-emergency services to residents and visitors. The City of Burnet staff works very closely with the Burnet Volunteer Fire Department to provide services to 6.8 square miles of the City as well as 321 square miles of the county. Services include fire suppression, fire prevention, rescue, hazardous materials responses, and public education. They also provide mutual aid to nine other fire departments located in Burnet County.

The Burnet EMS system is based in the City of Burnet and covers a service area of approximately 570 square miles of primary response coverage and approximately 22 square miles of ALS back-up coverage. The system offers emergency response, non-emergency transport and public information programs.

Police Department

The Burnet Police Department is responsible for a coverage area through the City's Extra Territorial Jurisdiction (one mile outside the current City Limit). The City also maintains Mutual Aid Agreements with County, State and other local law enforcement agencies. The BPD offers community outreach programs including Home Security Surveys, Youth Programs, Senior Crimes, Operation Identification and Neighborhood Watch programs. Contact the BPD for non-emergency issues by calling (512) 756-6404.

MUNICIPAL COURT

The Burnet Municipal Court provides assistance to defendants charged with Class C Misdemeanors. Citizens who have received citations from the Burnet Police Department, Burnet Code Enforcement, Burnet Animal Control and/or other City enforcement entities will have their cases heard at the Burnet Municipal Court.

The Court Offices are located at the City of Burnet Municipal Offices, 1001 Buchanan Drive, Suite 4, in Burnet. The court offices are open from 8:00 a.m. until

5:00 p.m., Monday through Friday except during official City holidays. The Clerk's office maintains an automated voice message system that provides the answers to most questions including court times and location. Pre-trials and trials are held at the City Council Chambers located at Kate Craddock Field, 2302 S. Water (Highway 281 South). Call (512) 756-2822 to activate the Voice Mail System. Many citations can be paid online (see City Web Site below.)

CITY COUNCIL MEETINGS

City Council meetings are typically held on the second and fourth Tuesday's of each month at the Council Chambers, Kate Craddock Field, 2302 S. Water (Highway 281 South) at 6:30 p.m. Watch the City's website for posting of special meetings.
