The City of Burnet is seeking to enter into a professional services contract with a competent professional administration/management firm/consultant to assist the City in the overall management of the TDEM DR-4705 Winter Storm grant. The following outlines the request for proposals.

4. Statement of Qualifications- The City is seeking to contract with a competent professional administration/management firm/consultant with experience in grants/contracts administration and project management. Specifically, it is seeking those consultant(s) or firm(s) with the following qualifications:

- Related experience in managing federally funded local public works construction projects, and
- Related Experience / Background with specific programs and associated project types; and
- Consultant/Firm is not debarred or suspended from the Excluded Parties List System (EPLS) in the System for Award Management (SAM).
