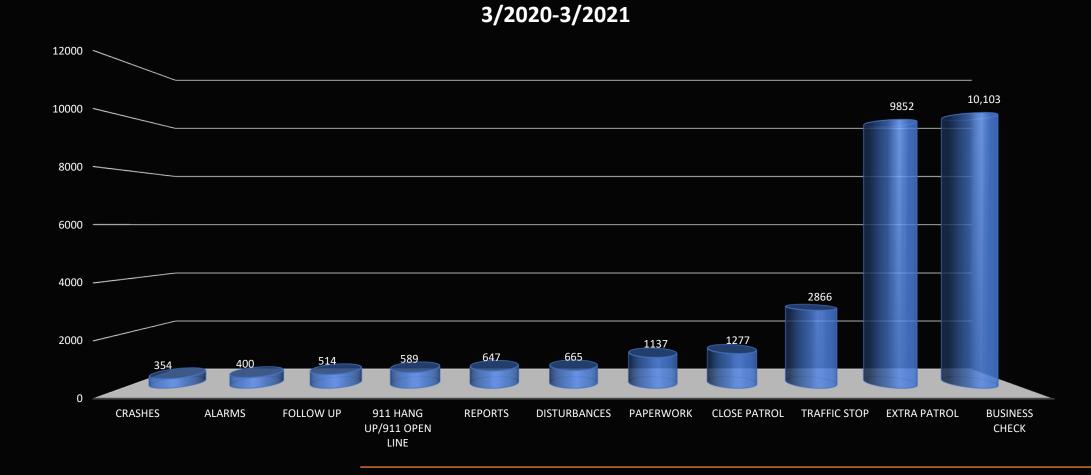

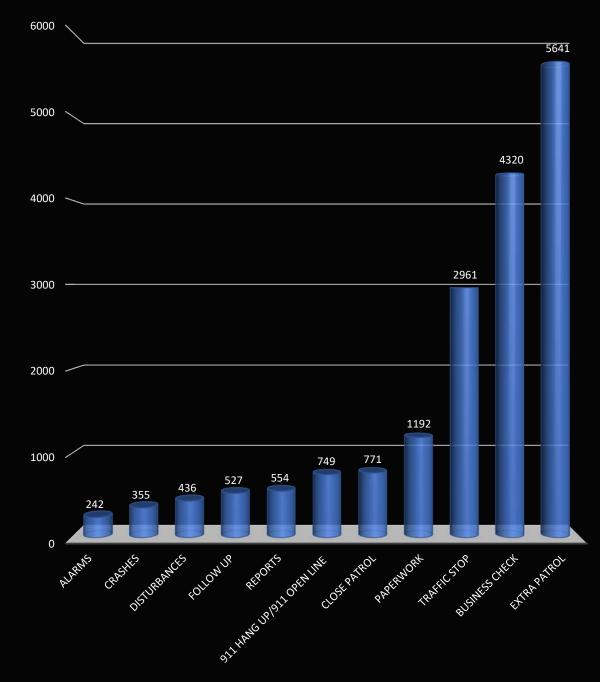
## Most common calls 03/2020-03/2021

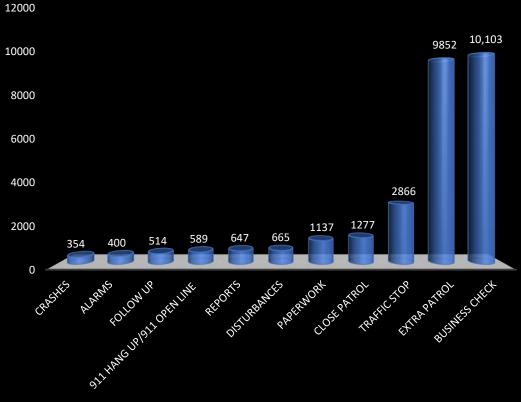
## Previous 9 months

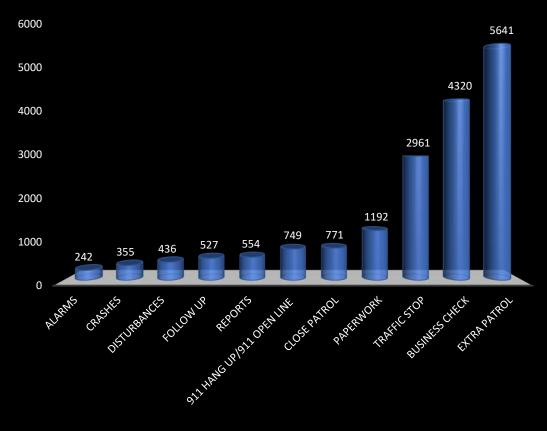


# Comparison

# Takeaways

- 911 hang up or open lines have increased 50% in comparison to the previous 12 months.
- Crashes are up 20% this year.
- Follow up, reports, and paperwork have all increased contributing to more allocated time with those areas being up 19%, 14%, and 24% respectively.
  - Focus of creating more well-rounded patrol officers by pushing investigations back to patrol.
- Traffic stops are up by 38%
  - This is with reduced staffing over the past three months.
- Time spent on each incident has also increased 14% which can be attributed to the follow up directive.
- Calls for service are trending at a 10% increase over the previous 12-month period.
- Officers allocated time is increasing based on new direction.

#### **GENERAL FUND**

The General Fund ended the first quarter with a profit of \$642,516 which is better than expected for this time mainly because of increasing revenue collections.

Property tax collections came in strong in December. In total they are tracking at 42% of budget and have increased by over \$718,000 compared to last year because of the timing of collections. Sales tax revenues have continued to trend upward. They have increased 15% over last year and are tracking about \$70,000 over budget. EMS transfer revenues have increased over last year and are tracking at about \$82,000 above budget. Transfers In from other funds have decreased slightly from last year and are tracking at 23% of budget which is typical for this time of year. Overall Revenues are tracking at 30% of budget.

The General Fund expenditures in total are on track for this time at 26% of budget.

#### **GOLF COURSE**

The Golf Course ended the quarter with a profit of \$168,233 which is a \$70,523 improvement over this time last year.

Revenues are tracking higher than expected because the bulk of Annual Charges are received in October and because the Green Fee/Cart Rental revenues have continued to increase. The number of Green Fee Rounds played is running consistent with last year, but the Green Fee Revenue per Round has increased from \$31.46 to \$37.96. Compared to this time last year Green Fee/Cart Rental revenues have increased by about \$44,000.

Expenses in total are on track for this time at 26% of budget.

Overall, the Golf Course had an excellent first quarter.

#### ELECTRIC FUND

The Electric fund ended the quarter with a loss of \$(39,667). Both revenues and expenses are on track with the budget for this time of year and YTD consumption is running consistent with last year.



#### WATER/WASTEWATER

The Water/Wastewater fund ended the quarter with a profit of \$170,232. Both revenues and expenses are tracking very well with the budget for this time of year and compared to last year, consumption has decreased by about 6%.

#### AIRPORT

The Airport Fund ended the quarter with a profit of \$50,337 and both revenues and expenses are tracking well with the budget for this time.

Compared to last year, Avgas gallons sold have increased by almost 31% and jet gallons sold have increased by 82%.

#### UNRESTRICTED CASH RESERVES

Total unrestricted cash for the City as of December 31st was \$8,449,104.22. That is \$4,227,104 above our 90-day required reserve amount.

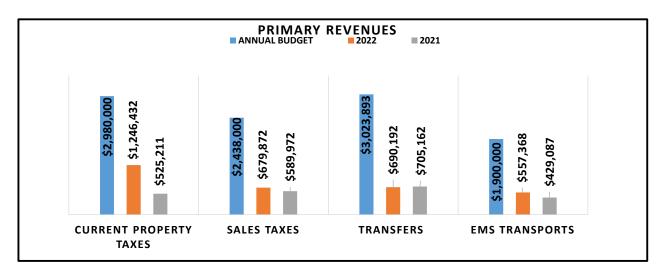
In addition to the unrestricted cash balance, the City has \$3,351,836 remaining in accounts restricted by council. Those accounts include the self-funded equipment reserve, capital equipment reserve, LCRA credit reserve, and the \$793,680 received from the American Rescue Plan.

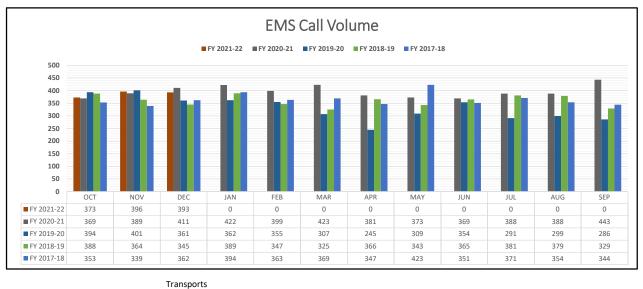

-The bulk of property taxes are collected in December and January of each year.

-Grant revenues are tracking higher than expected because we received \$7,864 from FEMA related to reimbursements from the 2018 flood that the City partnered with the County on.

-Other Revenues are tracking higher than expected because we received \$43,382 in delinquent field rental fees from the YMCA.

- Use of Fund Balance offsets Transfers to Capital/Other Exp, therefore the net impact of these adjustments is zero.

#### KEY VARIANCES - BUDGET vs ACTUAL (25% of Year Complete)

#### Expenditures

-Council Designated Expenses include "travel and training" for TML which was held in October.

-Police Other Designated Expenses are tracking higher than the average because of the timing of the purchase of non-capital equipment and travel and training. Ballistic vests were purchased in October and additional weapons were purchased in November. Officers attended several trainings and programs in October including Police Week (honoring Jose Meza), Sergeant Academy, FTO training, and Detective school.

-Fire/EMS Repairs and Maintenance are tracking higher than average mainly because they had to replace a Water Heater at Station 1 and they paid for their annual Fire reporting software maintenance in full in December.

-Street Supplies and Materials are tracking higher than average because of the purchase of new Traffic control signs in October and an increase in Fuel costs mainly from hauling base to Rhomberg and Cemetary.

-Development Services Other Designated Expenses include abatements which are tracking higher than expected due to a large clean up of a residence; and in addition, they include the purchase of a new plotter for the department.

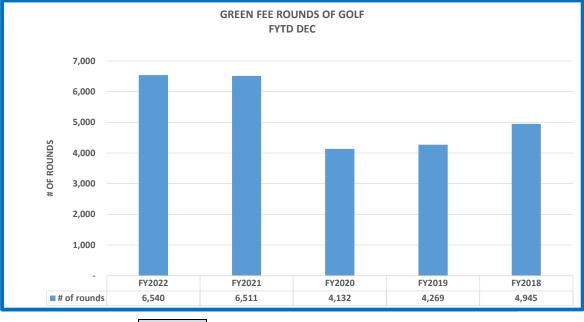

- Information: The tract (Exhibit A) is located outside the city limits within the City's ETJ. The applicant is proposing to subdivide the tract to create a 26 lot singlefamily residential subdivision which will establish The Headwaters of the San Gabriel, Phase Two. (Exhibit B).

The new subdivision will create one new street with a dead-end cul-de-sac named Classic Dash. Classic Dash will gain access to County Road 333 from the private road First Down Dash. The proposed cul-de-sac length exceeds the allowable length in the City of Burnet's code of ordinances and the requested variance must be approved prior to the preliminary plat's approval.

All the lots within the proposed subdivision will be approximately 1 acre in size. Each lot will be served by an On-Site Septic Facility; electric will be provided by Pedernales Electric Coop and water will be served by the City of Bertram. Currently, the City of Bertram is reviewing the water layout for the subdivision to ensure it meets their requirements.

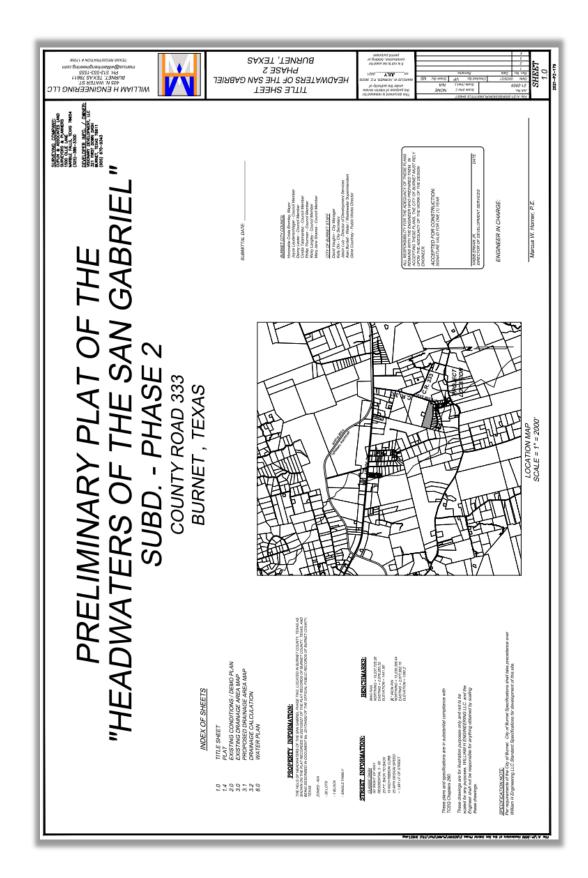
- **Staff Analysis:** City staff and city engineer have reviewed the plat in accordance with Sec. 98-22 (entitled "Preliminary Plats") and have found the plat does generally meet the requirements as outlined in the code; however, the applicant will need to secure an easement from the Headwaters of the San Gabriel, Phase One HOA to provide access into the proposed subdivision via a private easement. Additionally, since the water is being provided to the proposed subdivision from the City of Bertram, they will need to complete their review and approve the proposed utility layout prior to the acceptance of the final plat.
- **P&Z Report:** P&Z conducted a scheduled public hearing on January 3, 2022 and recommended conditional approval of the Preliminary Plat of The

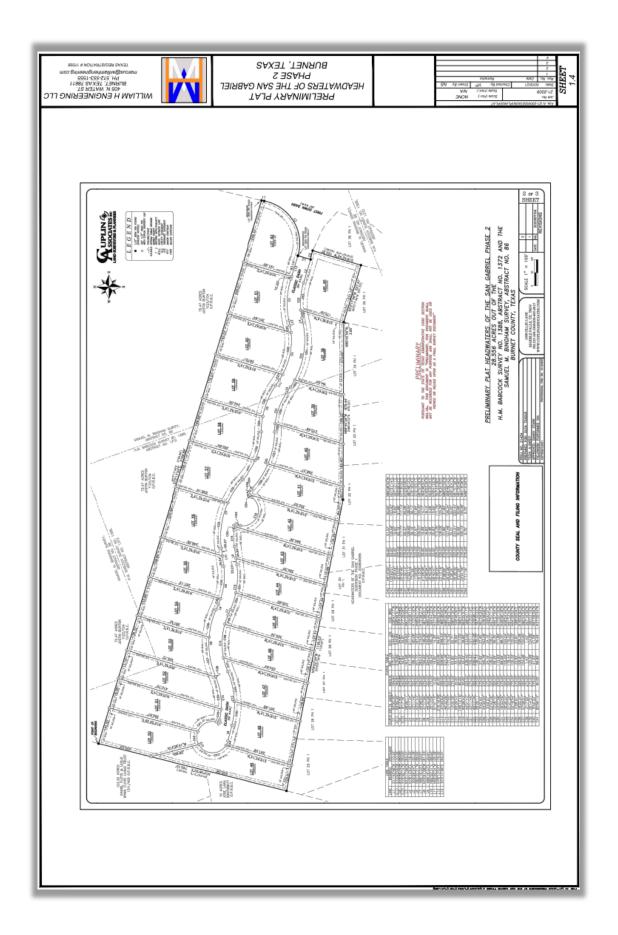
Headwaters of the San Gabriel, Phase Two, subject to the applicant securing the easement into the subdivision and final approval of the water layout from the City of Bertram.

Exhibit "B" Plat





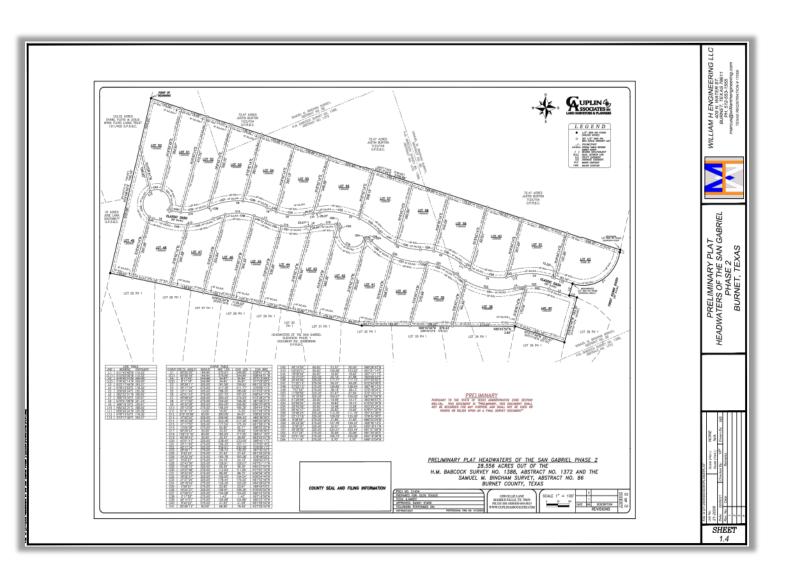

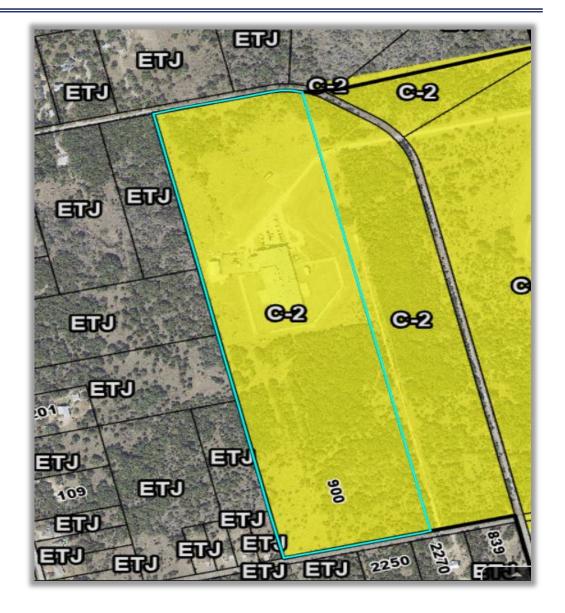

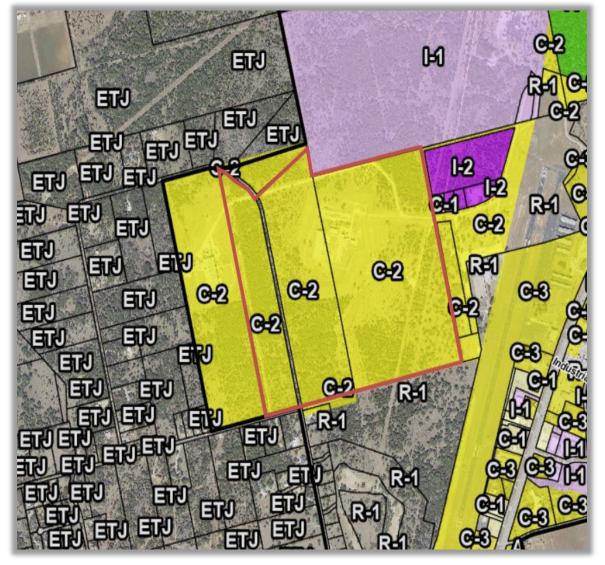

Information: A General Election will be held on May 7, 2022, to fill the vacancies. This election will be held in compliance with the laws established by the Texas Election Code and the State of Texas.

**WHEREAS**, on May 7, 2022 there shall be elected the following officials for this City: three City Council Members;

Gov't Code* (the "Election Agreement" or "contract"), jointly with Burnet Independent School District and any other political subdivisions that hold elections on the same day in all or part of the same territory of the City, as authorized in *Chapter 271, Tex. Elec. Code;*

**SECTION 1.** <u>General Election</u>. The General Election of the City shall be held on Saturday, May 7, 2022, to elect three City Council Members, to serve a term of two (2) years each. Candidates at the election for the above offices shall file their application to become

candidates with the City Secretary of the City of Burnet, at City Hall, 1001 W. Buchanan, Ste. 4, Burnet, Texas 78611, between 8:00 a.m. on January 19, 2020 and 5:00 p.m. on February 18, 2022. All applications for candidacy shall be on a form as prescribed by the *Tex. Elec. Code*. The order in which the names of the candidates for each office are to be printed on the ballot shall be determined by a drawing conducted by the City Secretary.

**SECCIÓN 1.** <u>Elección General</u>. **SECTION 2.** Notice of the election shall be given and the election shall be held in compliance with the provisions of the *Tex. Elec. Code* in all respects. The ballots for the election shall comply with the *Tex. Elec. Code* and be in the form provided by the City to the Burnet County Clerk for use on the voting devices and ballots used by Burnet County.

Elec. Code*, shall be prepared in both the English and Spanish languages and shall contain such provisions, markings and language as is required by law.

Early voting by personal appearance shall be conducted at the times, places, and locations authorized by state law and the Burnet

County Clerk. Early voting shall commence on Monday, April 25<sup>th</sup>, 2022 and continue through Tuesday, May 3, 2022. Early voting shall also be held at any time and location authorized by the Burnet County Clerk.

The polls shall remain open on the day of the election from 7:00 a.m. to 7:00 p.m. The returns for precincts in Burnet County will be provided by precinct and the Burnet County Clerk shall tabulate and provide the election returns for the election.

The City Secretary is further authorized to give or cause to be given notices required for the election, and to take such other and further action as is required to conduct the election in compliance with the *Tex. Elec. Code* and *City Charter*, provided that, pursuant to the Election Agreement between Burnet County and the City, the Burnet County Clerk shall have the duty and be responsible for organizing and conducting the election in compliance with the *Tex. Elec. Code*; and for providing all services specified to be provided in the Election Agreement. The Burnet County Clerk shall give the notices required by the *Tex. Elec. Code* to be given for the election not required to be given by the City under the Election Agreement.

- **Background**: City parks operate between the hours of 6:00 a.m. and 10:00 p.m. Occasionally there have been incidents of afterhours loitering and criminal activity. Additionally, complaints have been lodged that persons not using Randy Longoria Park are using the parking lot to park or store vehicles.
- Information: This ordinance prohibits parking motor vehicles in any city park between the hours of 10:00 p.m. and 6:00 a.m. In addition the ordinance prohibits person not using Randy Longoria Park from parking in the park's parking lot.
- **Fiscal Impact**: There will be a small cost associated with the procurement and installation of no parking signs.
- **Recommendation**: Approve the first reading of Ordinance No. 2022-05, as presented.

#### ORDINANCE NO. 2022-05

AN ORDINANCE OF THE CITY COUNCIL OF BURNET, TEXAS AMENDING THE CODE OF ORDINANCES, CHAPTER (ENTITLED "PARKS AND RECREATION") BY ADDING A NEW SECTION 74-10 PROHIBITING PARKING IN CITY PARKS AFTER HOURS AND PROHIBITING PARKING IN RANDY LONGORIA PARK BY PERSONS NOT USING THE PARK; PROVIDING FOR PENALTY; PROVIDING CUMULATIVE, REPEALER AND SEVERABILITY CLAUSES; PROVIDING FOR PUBLICATION; AND PROVIDING AN EFFECTIVE DATE

**Whereas,** City Council is authorized to make rules and regulations to regulate the use of City Parks pursuant to its inherent powers as the governing body of a home rule municipality and the laws and constitution of the state; and

**Whereas**, City Council is authorized to make rules and regulations to regulate the use of City Parks pursuant to its inherent powers as the governing body of a home rule municipality and the laws and constitution of the state; and

**Whereas**, City Council deems it appropriate to prohibit after hours parking in City Park parking lots as a deterrent to loitering and criminal activity; and

**Whereas**, City Council has received complaints that neighbors are using the Randy Longoria parking lot for parking and storing vehicles to such extent that at times there is not adequate parking to serve park patrons; and

**Whereas**, after investigation of the complaints, City Council deems it appropriate to limit the use of Randy Longoria Park parking lot to citizens visiting the park to assure adequate parking for Randy Longoria Park patrons; and

**Whereas**, City Council finds, determines, and declares that the meeting at which this Ordinance is adopted was conducted in compliance with the Texas Open Meeting Act; and

**Whereas**, City Council finds, determines, and declares the City Secretary has caused the caption of this ordinance, with a summary to be published in compliance with City Charter Section 3.14.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS:

**Section One. Code Amendment.** City Code Chapter 74 (entitled "*Parks and Recreation*") Article I (entitled "General") is hereby amended by adding a new Section 74-10 (entitled "*Parking*") to read as follows:

Sec. 74-10. - Parking

- (a) *Parking*. City Park parking lots are established and maintain for the convenience of City Park patrons. Therefore, the parking of vehicles within a City Park shall be subject to each of the regulations that follow:
  - (1) It shall be unlawful to cause a vehicle to be parked within a City Park, except in a designated parking area.
  - (2) It shall be unlawful to cause a vehicle to be parked within a City Park after park hours of operation.
  - (3) It shall be unlawful to cause a vehicle to be parked within Randy Longoria Park and then leave the premises of the City Park.
- (b) Signs. The City Manager shall cause signs to be placed at each entrance of City Parks warning that vehicles parked between the hours of 10:00 p.m. to 6:00 a.m.; and vehicles park at Randy Longoria Park in violation of subsection (a) (3) shall be subject to a fine not to exceed \$200.00 for each day of violation.
- (c) *Criminal Penalty*. Violation of subsections (c) and (d) of this Section, is a misdemeanor subject to criminal penalties as prescribed in City Code Section 1-6.

**Section Two. Findings**. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Ordinance for all purposes and are adopted as a part of the judgment and findings of the Council.

**Section three. Penalty.** A violation of this ordinance is unlawful and subject to City Code of Ordinances Sec. 1-6 (entitled "*general penalty*").

**Section four. Cumulative.** This ordinance shall be cumulative of all provisions of all ordinances and codes, or parts thereof, except where the provisions of this Ordinance are in direct conflict with the provisions of such Ordinances, in which event Section 5, (entitled "Repealer") shall be controlling.

**Section five. Repealer**. All ordinances and codes, or parts thereof, which are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters resolved herein.

**Section six. Severability**. If any provision of this Ordinance or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Ordinance and the application of such provision to other persons and circumstances shall nevertheless be valid, and the City hereby declares that this Ordinance would have been enacted without such invalid provision.

**Section eight. Publication**. The publishers of the City Code are authorized to amend said Code to reflect the changes adopted herein and to correct typographical errors and to format and number paragraphs to conform to the existing Code.

**Section nine. Effective Date**. This Ordinance shall be effective upon the date of final adoption hereof.

Kimbler
- **Background:** The proposed Preliminary Plat of Headwaters of the San Gabriel, Phase Two is a single-family residential subdivision on 28.556 acres of property located in the City's ETJ off County Road 333. The proposed subdivision will create 26 one-acre residential lots.

The subdivision will gain access from a private road, named First Down Dash, via the proposed new road Classic Dash. Classic Dash is a proposed dead-end cul-de-sac with an approximate length of 1991 linear feet.

Information: The first requested variance pertains to the requirements outlined in Code of Ordinances Sec. 98-42(b)(8), which states: "In general, culsde-sac shall not exceed 600 feet in length and shall have a turnaround of not less than 96 feet in diameter in residential areas, and not less than 100 feet in diameter in commercial and industrial areas and be in compliance with the city's adopted fire code."

> The second requested variance is to the City of Burnet's Technical Construction Standards, Section 292, which would require large lot subdivisions to install a streetlight at the main entrance to the subdivision.

> The City of Burnet Code of Ordinances Sec. 98-82 states the following regarding variances to the subdivision standards:

"In granting approval of a request for variance, the Commission and Council shall conclude that the variance is not contrary to the public interest and, due to special conditions, a literal enforcement of this chapter would result in unnecessary hardship, and so that the variance observes the spirit of this chapter and concludes that substantial justice is done. The Commission and Council shall meet these requirements by making findings that:

a. The public convenience and welfare will be substantially served;

b. The appropriate use of surrounding property will not be substantially or permanently impaired or diminished;

c. The applicant has not created the hardship from which relief is sought;

d. The variance will not confer upon the applicant a special right or privilege not commonly shared or available to the owners of similar and surrounding property;

e. The hardship from which relief is sought is not solely of an economic nature;

f. The variance is not contrary to the public interest;

g. Due to special conditions, the literal enforcement of this chapter would result in an unnecessary hardship; and

h. In granting the variance the spirit of the ordinance is observed and substantial justice is done."

- **Staff Analysis:** Staff has coordinated with the City of Burnet Fire Chief who stated that the fire department does support the requested variances. Staff has also evaluated the variance requests and has determined that, due to the limited access onto the property, the development of Phase One, the existing layout of the property, and the rural nature of surrounding properties, the requested variances would meet the criterion of the code.
- **P&Z Report:** P&Z recommended approval of the requested variances at its regularly scheduled meeting on January 3, 2022.

**Recommendation:** Staff recommends approval of resolution R2022-10 as presented.

**Section one. Recitals.** The recitals to this Resolution are incorporated herein for all purposes.

Section two. Findings. As required by City Code Sec. 98-82 City Council finds:

- Granting the variance is not contrary to the public interest: as streetlights are not installed in Headwaters of San Gabriel, Phase One and the subdivision is in a rural, gated area with limited traffic and access to the property.
- The literal enforcement of this chapter would result in unnecessary hardship: as the installation of streetlights would interfere with neighboring property owners', the property is landlocked only allowing one entrance onto the property and the additional length of the culs-de-sac allows for better use of the land.
- The variance observes the spirit of the chapter and concludes that substantial justice is done: By granting this variance, the spirit of the code is observed, ad substantial justice is done

Section three. Approval. The variance request is hereby approved and granted.

**Section four. Open Meetings.** It is hereby officially found and determined that the meeting at which this resolution was passed was open to the public and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.

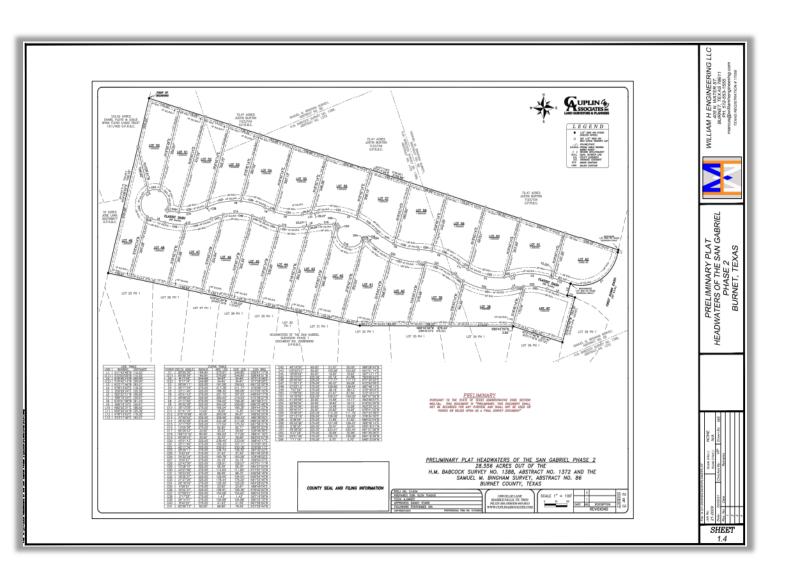

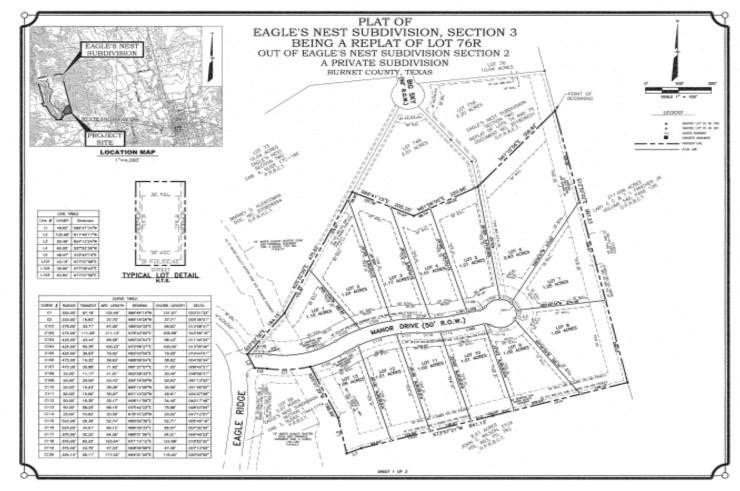

- Information: The tract is located outside the city limits within the City's ETJ. The applicant is proposing to subdivide the tract to create a 26-lot single-family residential subdivision which will establish The Headwaters of the San Gabriel, Phase Two.

The new subdivision will create one new street with a dead-end cul-de-sac named Classic Dash. Classic Dash will gain access to County Road 333 from the private road First Down Dash. The proposed cul-de-sac length exceeds the allowable length in the City of Burnet's code of ordinances and the requested variance must be approved prior to the preliminary plat's approval.

All the lots within the proposed subdivision will be approximately 1 acre in size. Each lot will be served by an On-Site Septic Facility; electric will be provided by Pedernales Electric Coop and water will be served by the City of Bertram. Currently, the City of Bertram is reviewing the water layout for the subdivision to ensure it meets their requirements.

- **Staff Analysis:** City staff and city engineer have reviewed the plat in accordance with Sec. 98-22 (entitled "Preliminary Plats") and have found the plat does generally meet the requirements as outlined in the code; however, the applicant will need to secure an easement from the Headwaters of the San Gabriel, Phase One HOA to provide access into the proposed subdivision via a private easement. Additionally, since the water is being provided to the proposed subdivision from the City of Bertram, they will need to complete their review and approve the proposed utility layout prior to the acceptance of the final plat.
- **P&Z Report:** P&Z conducted a scheduled public hearing on January 3, 2022, and recommended conditional approval of the Preliminary Plat, The

Headwaters of the San Gabriel, Phase Two, subject to the applicant securing the easement into the subdivision and final approval of the water layout from the City of Bertram.

**Recommendation:** Staff recommends approval of resolution R2022-11.

- Information: Staff reviewed the current policy for compliance with "The Public Funds Investment Act" and no significant changes were made.

#### **RESOLUTION NO. R2022-12**

#### A RESOLUTION ADOPTING THE CITY OF BURNET, TX, INVESTMENT POLICY AND NAMING THE FINANCE DIRECTOR AND SENIOR ACCOUNTANT AS THE INVESTMENT OFFICERS.

WHEREAS, Chapter 2256 of the Government Code, commonly known as the "Public Funds Investment Act, " requires the city to adopt an investment policy by rule, order, ordinance, or resolution; and

**WHEREAS**, the Public Funds Investment Act requires the investment officers of the city to attend investment training; and

**WHEREAS**, the City of Burnet approves the investment training course sponsored by the Texas Municipal League; and

WHEREAS, the investment officers of the city, have attended an investment training course sponsored by the Texas Municipal League as required by the Public Funds Investment Act; and

WHEREAS, the attached investment policy and incorporated strategy comply with the Public Funds Investment Act and authorize the investment of city funds in safe and prudent investments.

#### NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS:

That the City of Burnet has complied with the requirements of the Public Funds Investment Act, and the Investment Policy, attached hereto as "Exhibit A," is hereby adopted as the investment policy of the city effective January 25, 2022.

#### CITY OF BURNET INVESTMENT POLICY

The investment policy of the City is to invest public funds in a manner which will provide the highest investment return with the maximum security while meeting the daily cash flow demands of the City and conforming with all state and local statutes governing the investment of public funds.

#### SCOPE

The investment policy applies to investment activities of all funds of the City and all funds under the control of the City.

Funds covered by this policy are as follows:

All funds

#### OBJECTIVES

The primary objectives, in priority order, of the City's investment activities are:

- 1. Safety. Safety of principal is the primary objective of the investment transaction. Investments shall be made in a manner that seeks to ensure the preservation of capital in the overall portfolio.
- 2. Liquidity. The City's investment portfolio shall remain sufficiently liquid to enable the City to meet all operating requirements, which might be reasonably anticipated.
- 3. Return on investment. The City's investment portfolio will be designed with the objective of attaining a rate of return commensurate with the City's investment risk restraints and the cash flow operating requirements.
- 4. Diversification. Diversification may be required in order that potential losses on individual securities do not exceed the income generated from the remainder of the portfolio.

#### STANDARD OF CARE

Investments will be made with judgment and care, under circumstances then prevailing, which persons of prudence, discretion and intelligence exercise in the management of their own affairs, not for speculation, but for investment, considering the probable safety of their capital as well as the probable income to be derived.

#### **DELEGATION OF AUTHORITY**

Authority to manage the City's investment program is derived from state statutes and City resolutions. The Investment Officers for the City of Burnet shall invest and reinvest funds of the City in accordance with the City's investment policy. The Investment Officers shall be responsible for all transactions undertaken and shall establish a system of controls to

regulate subordinate officials. The Investment Officers currently designated by the City Manager are Patricia Langford, Director of Finance and Stefani Wright, Senior Accountant.

#### **INVESTMENT TRAINING**

It is the City's policy to provide training required by the Public Funds Act, Sec. 2256.008 of the Government Code for the City's Investment Officers. The Investment Officers shall attend at least one training session within twelve months after taking office or assuming duties. In addition, they shall participate in an investment training session not less than once in a two year period consisting of not less than 8 hours of instruction. Training includes education in investment controls, security risks, strategy risks and compliance with the Public Funds Investment Act.

#### ETHICS AND CONFLICTS OF INTEREST

An Investment Officer who has a personal business relationship with an entity seeking to sell an investment to the City will file a statement disclosing that personal business interest. An Investment Officer who is related within the second degree by affinity or consanguinity, as determined under Chapter 573, to an individual seeking to sell an investment to the City shall file a statement disclosing that relationship. These statements must be filed with the Texas Ethics Commission and the City Council.

#### COLLATERALIZATION

All funds must be insured by the FDIC or FSLIC or by collateral pledged to the extent of the fair market value of any amount not insured. To the extent not insured by the FDIC or FSLIC, City funds must be secured by direct obligations of the United States backed by the full faith and credit of the government or by governmental securities or obligations issued by the State of Texas, its agencies or political subdivisions. Collateral will be held by an independent third party, and a safekeeping receipt will be supplied to the City. The City's bank depository will provide the City with a report on the collateral pledged, and a City representative will have the right to inspect the pledged collateral at any time. Collateral may be substituted; however, the City must approve any substitution of collateral in writing.

#### INVESTMENT POLICY DISCLOSURE

A written copy of the City's investment policy shall be presented to any person seeking to sell to the City an authorized investment. The registered principal of the business organization seeking to sell an authorized investment shall execute a written instrument substantially to the effect that the registered principal has received and thoroughly reviewed the Investment Policy of the City and acknowledged that the organization has implemented reasonable procedures and controls in an effort to preclude imprudent investment activities arising out of investment transactions conducted between the City and the organization. The Investment Officers of the City may not buy any securities from a person who has not delivered to the City a written document providing the above information.

#### AUTHORIZED INVESTMENTS

Investments described below are some of those authorized by the Public Funds Investment Act and considered suitable for investment of City funds:

- 1. Obligations of the United States or guaranteed by the United States. The City may invest in funds in obligation of the United States or its agencies and instrumentalities.
- 2. Certificates of Deposit. The City is authorized to invest its funds in certificates of deposit or other interest bearing accounts of any bank or savings and loan association domiciled in the State of Texas. All certificates of deposit must be fully insured or collateralized. Certificates of deposit should mature one to twenty-four months after purchase with maturity dates falling one to six months apart.
- 3. Public Funds Investment Pools. The City is authorized to invest in public fund investment pools which strive to maintain a stable \$1.00 net asset value and maintain either a "AAA" or "AA" rating from a nationally recognized rating agency.

#### **INVESTMENT STRATEGIES**

Investment strategies are developed to attain the investment objectives of the City.

#### GENERAL FUND AND ENTERPRISE FUNDS

The investment objectives of the City are as follows:

- 1. Safety of Principal
- 2. Liquidity. Availability of funds to meet the monthly operating expenditures of the City in accordance with budgeted expenditures and availability of funds to meet unexpected expenditures.

To attain these objectives, investments should be short term that can be liquidated to assure adequate cash flows as necessary. The weighted average maturity should be 180 days or less.

#### CAPITAL PROJECTS FUND

The investment objectives of the capital projects fund are as follows:

- 1. Safety of Principal
- 2. Availability of funds to meet construction needs of the City.

To attain these objectives, investment maturities should be structured to mature no later than the date funds will be needed for project payments.

#### DEBT SERVICE FUNDS

Investment objectives of the debt service funds are as follows:

- 1. Safety of Principal
- 2. Liquidity
- 3. Yield

Since payment of debt is one of the highest priorities of the City, safety of principal should be of the highest priority when selecting an investment. To ensure safety, investments should consist of United States Treasury notes and bills, public fund investment pools, and certificates of deposit. The investment should have a weighted average maturity of 365 days or less and should be structured to insure that the necessary amounts to retire debt on each date will mature 5 days before said due date.

#### **INVESTMENT REPORTS**

No less than quarterly, the Investment Officers shall prepare and submit to the City Council a quarterly written investment report. The report must describe in detail the investment position of the City on the date of the report, state the book value and fair market value of each separately invested asset at the beginning and end of the reporting period by the type of asset and fund type invested. #### COMPLIANCE AUDIT

The City, in conjunction with its annual financial audit, shall perform a compliance audit of management controls on investments and adherence to the City's Investment Policy.

Erkan
- **Background**: City Code Chapter 50 was adopted by Council to, inter alia, to protect new and existing development from the risks of storm water damage. To assist with meeting this objective, Council adopted Sec. 50-56 to provide standards for finished floor elevations on individual lots. This ordinance amends Sec. 50-56.
- **Information**: The drafting of this ordinance was a collaborative effort of the city engineer and the Technical Advisory Forum. The Forum members and City Engineer recommend the adoption of this ordinance. The Planning and Zoning Commission considered this ordinance at a special called meeting held on January 5; and also recommends approval.

**Fiscal Impact:** No fiscal impact is anticipated.

**Recommendation:** Approve the first reading of Ordinance No. 2022-06 as presented.

#### ORDINANCE NO. 2022-06

AN ORDINANCE OF THE CITY COUNCIL OF BURNET, TEXAS, AMENDING CITY OF BURNET CODE OF ORDINANCES, CHAPTER 50 (ENTITLED "FLOOD DAMAGE PREVENTION") BY AMENDING SECTION 50-56 (ENTITLED ELEVATION AND LOT GRADING FOR STRUCTURES LOCATED IN ZONE X"); PROVIDING FOR PENALTY; PROVIDING CUMULATIVE, REPEALER AND SEVERABILITY CLAUSES; PROVIDING FOR PUBLICATION; AND PROVIDING AN EFFECTIVE DATE

**WHEREAS**, City Council, by adoption of City Code Chapter 50, established a regulatory scheme to protect existing and new development from the dangers of storm water diversion and impoundment; and

**WHEREAS**, Sec. 50-56. Therein regulates the elevation and lot grading standards for structures located in Zone X.; and

**WHEREAS**, the City's technical advisory forum have recommended amendments to Sec. 50-56, that will provide additional regulatory protections in a manner that will reduce the time and costs associated with compliance; and

**WHEREAS**, the City Engineer and the Planning and Zoning Commission recommends approval of this amendment; and

**WHEREAS**, City Council, finds, determines, and declares that publication of notice of this Ordinance, as required by Section 3.14 of the City Charter and the laws of the State of Texas, was made by the City Secretary within the period prescribed by Section 3.14; and.

**WHEREAS**, City Council, finds, determines, and declares that the meeting at which this Ordinance is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Ordinance, was given as required by Chapter 551 of the Texas Government Code.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, THAT:

**Section one. Amendment.** The Code of Ordinances, Chapter 50 (entitled "flood damage prevention") Section 50-56 (entitled "elevation and lot grading standards for structures located in Zone X") is hereby amended by adding the language that is underlined (<u>underlined</u>) and deleting the language that is stricken (stricken) as follows:

#### Sec. 50-56. Elevation and lot grading standards for structures located in Zone X.

(a) All walls and foundations of structures shall be provided with protective slopes to assure immediate drainage and diversion of surface water away from these structures and off the site, said drainage and diversion to be provided as follows:

- (1) The lowest finished floor elevation (inclusive of garages, enclosed porches, etc.) of all structures shall be elevated not less than six inches above highest adjacent, finished grade including topsoil and sod. At the time of setting the foundation formwork, which may be prior to final grade including topsoil and sod, the lowest finished floor elevation shall be elevated no less than twelve inches (12") above the highest adjacent grade.
  - a. Lots, as measured from highest adjacent grade, shall provide a minimum fall of at least six inches away from structures in ten feet, <u>except where length is</u> as restricted by side lot lines or other major considerations. The horizontal length of such slopes may be reduced as necessary at building corners and side yards; <u>provided however</u>, the minimum fall of six inches (6") shall be maintained at any length less than ten feet (10').
  - b. In cases where highest elevation adjacent to a building pad is determined to be lower than top of curb or edge of paving, whichever is higher, of any adjacent right-of-way, fall, as measured from highest adjacent grade shall be increased to a minimum of twelve inches (12") in twenty feet (20'). The horizontal length of such slopes may be reduced as necessary at building corners, side yards, and other major considerations; provided however, the minimum fall of twelve inches (12") shall be maintain at any length less than twenty feet (20').
  - c. <u>No more than two (2) average residential lots may drain onto another lot,</u> <u>unless a drainage easement is dedicated to contain stormwater runoff.</u>
- (b) Exceptions.
  - (1) Lowest finished floor is elevated at least one foot above the calculated depth of flooding based on a flood elevation study prepared by a registered professional engineer and documented by a registered professional land surveyor, <u>and</u> <u>approved by the City Engineer</u>; or
  - (2) Structure is being erected on a building pad prepared in accordance with an approved subdivision drainage plan Master Drainage Plan, detailed Lot Grading Plan, and approved subdivision infrastructure plan. The detailed Lot Grading Plan shall provide minimum finished floor elevations for each structure on each lot based on elevating the slab twelve inches (12") above the highest adjacent grade of the foundation pad area. The Lot Grading Plan shall also identify the typical FHA or HUD lot grading types.
  - (3) If an applicant proposes to set finished floor elevation of a structure at an elevation lower than the minimum elevation shown on the approved detailed Lot Grading Plan, matching the Master Drainage Plan, the applicant shall submit a detailed lot specific grading plan, prepared by a registered professional engineer, to adjust the elevation as proposed. The detailed lot specific grading plan shall, at a minimum, depict structure finished floor elevation and sufficient lot grading control elevations to determine if the structure will not be properly elevated above the adjacent grade. The lot specific grading plan shall be submitted to the City, before, or at the time of building permit application and must be approved by the City before a building permit may be issued.

**Section two. Findings**. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Ordinance for all purposes and are adopted as a part of the judgment and findings of the Council.

**Section three. Penalty.** A violation of this ordinance is unlawful and subject to City Code of Ordinances Sec. 1-6 (entitled "general penalty").

**Section four. Cumulative.** This ordinance shall be cumulative of all provisions of all ordinances and codes, or parts thereof, except where the provisions of this Ordinance are in direct conflict with the provisions of such Ordinances, in which event Section 5, (entitled "Repealer") shall be controlling.

**Section five.Repealer**. All ordinances and codes, or parts thereof, which are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters resolved herein.

**Section six. Severability**. If any provision of this Ordinance or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Ordinance and the application of such provision to other persons and circumstances shall nevertheless be valid, and the City hereby declares that this Ordinance would have been enacted without such invalid provision.

**Section seven. Publication**. The publishers of the City Code are authorized to amend said Code to reflect the changes adopted herein and to correct typographical errors and to format and number paragraphs to conform to the existing Code.

**Section eight. Effective Date**. This Ordinance shall be effective upon the date of final adoption hereof.

**Whereas**, the Creekfall Subdivision is proposed residential development located within the city's corporate limits; and

**Whereas**, city council finds, depending on costs, it may be appropriate to participate in oversizing infrastructure to be constructed for the Creekfall Subdivision .

# NOW, THEREFORE, BE IT RESOLVED BY CITY COUNCIL OF THE CITY OF BURNET, TEXAS, THAT:

**Section one. Findings.** The recitals to this Resolution are incorporated herein for all purposes.

**Section two.** Authorization. The city manager is hereby authorized to send the Creekfall Subdivision plat applicant notice of the city's intent to consider the oversizing of water and wastewater infrastructure and request the applicant provide an oversizing cost estimate within thirty days of receipt of the request. Upon receipt of the cost estimate the City Manager shall present same to this council who will then determine whether facility oversizing shall be required. To the extent the city manager determines appropriate he may negotiate the pricing shown on the applicant's cost estimate prior to presentation to this council.

**Section three. Open Meetings.** It is hereby officially found and determined that the meeting at which this resolution was passed was open to the public and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act.

Section four. Effective date. This resolution shall take effect immediately upon its passage, and approval as prescribed by law.

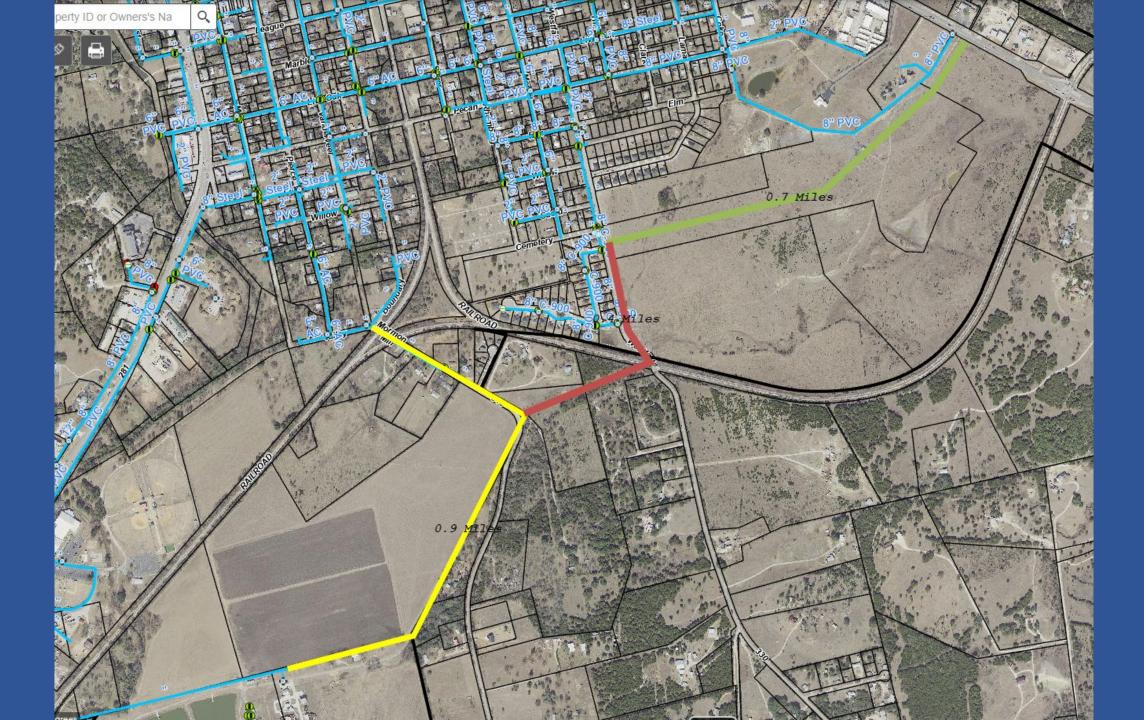

## **RESOLUTION NO. R2022-14**

## A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS AUTHROIZING THE PAYMENT OF A FEE IN LIEU OF TREE PRESERVATION/MITIGATION FOR DELAWARE SPRINGS SECTION 24

**Whereas,** City Code Section 98-22 requires a subdivision plat applicant in the development of his or her project to preserve trees within the subdivision that are eight caliper inches or larger ("significant trees"); and

**Whereas**, alternatively the Code Section allows the developer to mitigate the removal of significant trees by planting trees at a ratio of one caliper inch per each caliper inch removed, except in cases of significant trees being eighteen caliper inches the ratio is two caliper inches for each caliper inch removed;

**Whereas**, Delaware Springs Section 24 is a single family subdivision under development within the city of Burnet; and

**Whereas**, as part of the preliminary plat application the applicant provided a tree survey; and

**Whereas**, the applicant has removed 116 caliper inches of significant trees less than eighteen caliper inches, and 45 caliper inches of significant trees eighteen caliper inches or greater; and

**Whereas**, the applicant represents it is impractical to plant mitigation trees and requested to pay fee in lieu of mitigation; and

**Whereas**, there is precedence (Pepper Mill Sections 1&2) for accepting a fee in lieu of mitigation at the rate of \$100.00 per caliper inches for the removal of significant trees less than eighteen caliper inches and \$200.00 per caliper inches for significant trees eighteen caliper inches or greater.

# NOW, THEREFORE, BE IT RESOLVED BY CITY COUNCIL OF THE CITY OF BURNET, TEXAS, THAT:

**Section one. Findings.** The recitals to this Resolution are incorporated herein for all purposes.

**Section two**. **Authorization**. The City Manager is hereby authorized to accept payment in the amount of \$20,600.00 from the applicant as a fee-in-lieu of the tree mitigation required for the recordation of the subdivision plat of Delaware Springs Section 24; and apply such funds for the enhancement of vegetation on the City owned properties. The City Manager is further authorized to execute such instruments and take such actions as may reasonably be necessary to facilitate the purpose of this resolution. However, nothing in this resolution shall prevent the applicant from opting to mitigate the removed trees as authorized by the City Code rather than paying the fee-in-lieu or to fulfill his obligation under the City Code by a combination of mitigation and payment of fee-in-lieu.

**Section three. Open Meetings.** It is hereby officially found and determined that the meeting at which this resolution was passed was open to the public and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act.

**Section four. Effective date.** This resolution shall take effect immediately upon its passage, and approval as prescribed by law.

The base stipend for Captain will be \$8,000 for year 1, \$10,000 for year 2, and \$12,000 after the third year adjusting with the scale.

EMT's moving to paramedic will begin at the base salary for paramedic.

Years of service will be calculated as of October 1st of the then current fiscal year.

Any COLA approved by the City Council will adjust the base pay and the scale will move accordingly.

The City Manager may authorize pay higher than the minimums provided for herein for merit or other public purposes when it is deemed to be in the best interest of the City.

Patrol officers will be eligible for FTO pay. Promoted ranks will be required to train new officers as part of their duties.

Years of service will be calculated as of October 1st of the then current fiscal year.

Any COLA approved by the City Council will adjust the base pay and the scale will move accordingly.

The City Manager may authorize pay higher than the minimums provided for herein for merit or other public purposes when it is deemed to be in the best interest of the City.

Pay Scale is subject to annual appropriations by the City Council

Night Shift Differential Pay may be amended annually within the budget as approved by the City Council. (Currently \$1 per hour)

Certification levels are required at each step as indicated on the scale. If certification is not obtained by October 1st of the current fiscal year, progress in the scale will stop until certification is gained.
