Call to Order: Mayor Gary Wideman called the meeting to order at 6:00 p.m.

SPECIAL REPORTS/RECOGNITION:

5.1) Burnet Municipal Airport Quarterly Report: A. Feild

Airport Manager Adrienne Feild reported on current airport projects and activities:

- Paving Project: The paving project is nearing completion, with only minor warranty work remaining.
- Box Hangar Construction: The construction of the new box hangar is progressing on schedule and is anticipated to be completed by mid-July.
- Airport Property Platting: The platting process is nearing the conclusion of the research and review phase.
- Deceleration Lane Project: This project is currently on hold and will resume following the completion of the box hangar.
- Routine Airport Maintenance Program (RAMP): RAMP funding has assisted with the completion of several maintenance tasks, including repairs to hangar doors and upgrades to airport fencing.

In addition to the project updates, Mrs. Feild also provided information regarding the Highland Lakes Squadron – CAF, the current status of the CareFlite lease, and operations of the FBO, Crosby Flying Services.

5.2) May Financial Report: P. Langford

Finance Director Patricia Langford provided an overview of the City's financial status. The General Fund is performing well, with a current profit of \$2,252,191. The Golf fund and Electric fund are both showing a profit for the year and performing as expected. The Water/Wastewater fund is trending below the prior year, but is tracking in line with the current year's budget. Though temporarily closed for a paving project, the Airport is still showing a profit for the year.

The City's unrestricted cash balance is reported at \$2,692,268 above the 90 day reserve requirement. The restricted by Council cash reserve balance stands at \$5,993,207. Both reserves are in healthy condition, indicating strong fiscal stability.

Overall, the City's financial position is positive across all funds Cash reserves remain strong.
