Approval of the May 14<sup>th</sup>, 2013 Regular Council Meeting minutes.

Council Member Milton Phair made a motion to approve the consent agenda as presented. Council Member Paul Shell seconded, the motion carried unanimously.

## **CANVASS ELECTION:**

Discuss and consider action: A RESOLUTION AND ORDER BY THE CITY COUNCIL, OF THE CITY OF BURNET, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE CITY OF BURNET, MAY 11, 2013 GENERAL ELECTION: K. Herve Derek Fortin received 234, Pat Riddell received 125 votes, Mary Jane Shanes received 260 votes, Buddy Coker received 143 votes and Milton Phair received 220 votes. Herve Derek Fortin, Mary Jane Shanes and Milton Phair will fill the three open council seats. Council Member Philip Thurman made a motion to approve the resolution canvassing the returns and declaring the results of the May 11, 2013 General Election. Council Member Paul Shell seconded. The motion carried unanimously.
