<u>Hill Country Crime Stoppers:</u> Bill Weaver gave a brief description of the program and introduced the members of the board. Jamie Prew reviewed the statistical reports for 2013 to include the number of tips that led to arrests, types of arrests and the overall financial status of the organization.

<u>Tree of Angels Proclamation:</u> Mayor Gary Wideman presented the proclamation declaring December 7, 2013 Tree of Angels Day in the City of Burnet honoring victims of crime. CONSENT AGENDA ITEMS:

Addendum to the City Council Agenda: Department and Committee Reports/Briefings: The City Council may or may not receive a briefing dependent upon activity or change in status regarding the matter. The listing is provided to give notice to the public that a briefing to the Council on any or all subjects may occur.

<u>Project Update Report: L. Figueroa:</u> Ms. Figueroa reviewed the current status of the sewer plant facility construction which is currently running about fifty four days behind. A slide show presentation was provided as well.

<u>Fire Station Update Report: M. Ingram:</u> Chief Ingram briefed the Council on the current status of the new fire station facility to include a review of the current timeline and progress. The roofers have been delayed due to the inclement weather and are expected to be back on task when the freezing conditions subside. The South parking lot area has been addressed. The outside A/C units have been installed, the electrical is nearly completed and the fiber optics is the next targeted installation. Chief Ingram stated that Teal Construction and the City Building Official are monitoring progress closely.

<u>October 2013 Financial Report: D. Vaughn:</u> City Manager David Vaughn reviewed the fund balances and current debt and cash asset with the Council and reported that the fiscal outlook for the City through the end of October and the preliminary numbers for November are in line for this time of year. The final payment on the Galloway Hammond Recreational Facility will be made this month.

<u>REQUESTS FROM COUNCIL FOR FUTURE REPORTS</u>: City Manager David Vaughn stated that a January 30, 2014 grand opening will be held at the YMCA of the Highland Lakes at Galloway Hammond Recreation Center.

Council Member Milton Phair stated that he was scheduled to attend the Capitol Area Council of Governments end of the year meeting on September 12, 2013 and would brief Council at the next meeting of any new developments.
