<u>Approval of the December 8, 2022 Special Meeting minutes.</u> Board Member Habib Erkan, Jr. moved to approve the consent agenda as presented. Board Member Crista Bromley seconded; the motion carried unanimously.

# ACTION ITEMS:

<u>Certificate of Appropriateness for 304 South Main Street: Chase Watson:</u> Bobby and Cassandra Doyal addressed all present of their request to provide covered parking behind their building located at 304 South Main Street. Historic Preservation Officer Carly Kehoe explained the preservation requirements and building code of the City of Burnet Code of Ordinances. Board Member Habib Erkan moved to approve the requested modification of the carport cover to a maximum height of ten feet. Board Member Renee Riddell seconded. The motion carried unanimously.

Discuss and consider action: Sign determination for 205 S. Pierce Street: Cody Henson: Cody Henson presented photos and dimensions of the sign purchased for installation on his new facility at 205 South Main Street. Carly Pearson reviewed the required permit process and historic preservation guidelines for signage on the square. Discussion ensued. Board Member Habib Erkan moved to approve Mr. Henson working with the Historic Preservation Officer for framing solution to comply with historic preservation guidelines for properties in the historic district. Board Member Crista Bromley seconded. The motion carried unanimously.
