

## **RESOLUTION NO. R2025-58**

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF AGREEMENT WITH THE FEDERAL AVIATION ADMINISTRATION (FAA) FOR THE CONSTRUCTION, OPERATION, AND MAINTENANCE OF FAA NAVIGATIONAL, COMMUNICATION, AND WEATHER FACILITIES AT BURNET MUNICIPAL AIRPORT/KATE CRADDOCK FIELD; AND PROVIDING FOR RELATED MATTERS**

**WHEREAS**, the City of Burnet owns and operates the Burnet Municipal Airport/Kate Craddock Field, a public-use airport serving the City and surrounding communities; and

**WHEREAS**, the Federal Aviation Administration (FAA), acting on behalf of the United States of America, is authorized under 49 U.S.C. § 106(l)(6) and (n) to enter into agreements for the acquisition and use of real property for aviation-related purposes, including the construction and maintenance of facilities that support the National Airspace System (NAS); and

**WHEREAS**, the FAA has proposed a new On-Airport Memorandum of Agreement (MOA), Contract No. 697DCM-25-L-00062, for the purpose of constructing, operating, and maintaining FAA-owned facilities at the Burnet Municipal Airport, including but not limited to, the Precision Approach Path Indicator (PAPI) for Runway 19 and the Automated Surface Observing System (ASOS); and

**WHEREAS**, this MOA supersedes prior agreements between the City and the FAA, and establishes mutual responsibilities regarding rights-of-way, utility access, parking, maintenance, and non-interference with FAA operations, without any monetary consideration from the FAA; and

**WHEREAS**, the agreement is effective beginning October 1, 2025, and will continue through September 30, 2045, unless terminated earlier under the terms provided therein; and

**WHEREAS**, the City Council of the City of Burnet finds it to be in the public interest and consistent with the safe and efficient operation of the Airport to enter into this agreement.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, AS FOLLOWS:**

**Section One. Findings.** The recitals set out above are hereby approved and incorporated herein for all purposes.

**Section Two. Approval.** The City Council hereby approves the On-Airport Memorandum of Agreement (FAA Contract No. 697DCM-25-L-00062), attached hereto as **Attachment A**, between the City of Burnet and the Federal Aviation Administration.

**Section Three. Authorization.** The City Manager is hereby authorized to execute the MOA and any related documents necessary to implement the terms of the agreement and support the FAA's operations at Burnet Municipal Airport/Kate Craddock Field.

**Section Four. Open Meetings.** It is hereby officially found and determined that the meeting at which this resolution was passed was open to the public and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.

**Section Five. Effective Date.** That this resolution shall take effect immediately upon its passage, and approval as prescribed by law.
