

**ORDINANCE NO. 2013-04**

**AN ORDINANCE OF THE CITY OF BURNET, TEXAS, AMENDING CHAPTER 74, SECTIONS 74-1(e) AND ADDING SECTION 74-1 (F); AMENDING SECTION 74-5 IN THEIR ENTIRETY; ESTABLISHING MEMBERSHIP FEES; PROVIDING A SEVERABILITY CLAUSE; PROVIDING AN EFFECTIVE DATE AND AN OPEN MEETINGS CLAUSE; AND PROVIDING FOR RELATED MATTERS.**

**WHEREAS**, The City provides, or causes to be provided, recreational services to the City of Burnet and to the general public

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, THAT;**

**Section 1. Findings.** The foregoing recitals are hereby adopted by the City Council and made a part here of for all purposes as findings of fact.

**Section 2. Amendments.**

**Sec. 74-1. Galloway-Hammond Recreation Center Membership Fees**

Section 74-1 (e) shall be amended in its entirety, and adding Section 74-1 (f) to read as follows:

(e) *Council Members.* City of Burnet City Council Members, while serving on the Council, shall receive a discount on services of the lesser of (1) twenty percent; or (2) the maximum discount allowable as a Qualified Employee Discount for services in accordance with IRS regulations.

(f) *Lifetime Memberships.* All previous lifetime memberships are hereby repealed.

**Sec. 74-5. Delaware Springs Golf Course**

Section 74-5 shall be amended in its entirety to read as follows:

**Sec. 74-5. Delaware Springs Golf Course.**

(a) *Clubhouse rental.* The clubhouse at the golf course is eligible for rental, subject to availability, for a rental fee of \$200.00 per day and a \$100.00 deposit.

(b) *Council Members.* City of Burnet City Council Members, while serving on the Council, shall receive a discount on services of the lesser of (1) twenty percent; or

(2) the maximum discount allowable as a Qualified Employee Discount for services in accordance with IRS regulations.

(c) *Lifetime Memberships*. All previous lifetime memberships are hereby repealed.

**Section 3. Severability**. It is hereby declared to be the intention of the City Council that the section, paragraphs, sentences, clauses and phrases of this Ordinance are severable and, if any phrase, sentence, paragraph or section of this Ordinance should be declared invalid by the final judgment or decree of any court of competent jurisdiction, such invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation of this ordinance of any such invalid phrase, clause, sentence, paragraph or section. If any provision of this Ordinance shall be adjudged by a court of competent jurisdiction to be invalid, the invalidity shall not affect other provisions or applications of this Ordinance which can be given effect without the invalid provision, and to this end the provisions of this Ordinance are declared to be severable.

**Section 4. Effective Date** This ordinance shall be in force and effect from and after May 1, 2013.

**Section 5. Open Meetings** It is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act Chapt. 551. Tex. Gov't. Code.
