

ORDINANCE NO. 2016-11

AN ORDINANCE AMENDING ORDINANCE NO. 2012-06 BY REZONING 700 CEMETERY STREET WHICH IS FURTHER DESCRIBED AS THE WEST ONE-HALF OF LOT 2, BLOCK 48; VANDERVEER/ALEXANDER S8450 FROM ITS PRESENT DESIGNATION OF MANUFACTURED HOME – DISTRICT M-1 TO A DESIGNATION OF SINGLE-FAMILY RESIDENTIAL – DISTRICT R-1; PROVIDING A REPEALER CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, The Planning and Zoning Commission of the City of Burnet, on May 2, 2016, did conduct a public hearing for the purpose of taking public comment regarding the proposal to rezone 700 Cemetery Street which is further described as being the W ½ of Lot 2, Block 48, Vanderveer/Alexander S8450, from its present designation of Manufactured Home – District M-1. to a designation of Single-family Residential 1—District R-1.and

WHEREAS, The Planning and Zoning Commission, following public hearing did unanimously recommend approval of said zone change request; and

WHEREAS, The City Council has given due consideration to said Planning and Zoning Commission recommendation; and

WHEREAS, Based on these findings, the City Council has determined that approval of said zone change will be consistent with the best public interest of the City;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, THAT:

Section 1. Findings. The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes as findings of fact.

Section 2. Zoning Changed. 700 Cemetery Street which is described as being the W ½ of Lot 2, Block 48, Vanderveer/Alexander S8450, and further described by the March 31/April 19, 2016, Cuplin and Associates Survey identified as Project Number 16326, a copy of which is attached hereto as Exhibit A and incorporated for all purposes herein, is hereby rezoned form its present designation of Manufactured Home – District M-1, to a designation of Single-family Residential 1—District R-1.

Section 3. Repealer. That other ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent that they are in conflict.

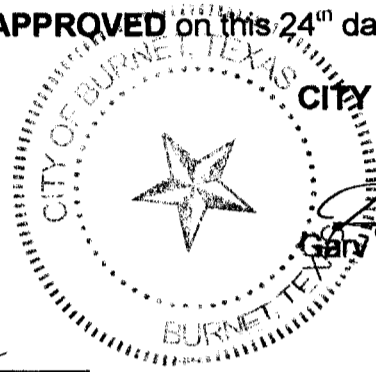

Section 5. Effective Date. That this ordinance is effective upon final passage and approval.


