

City Utilities

General Information

The City supplies electricity, water, wastewater and solid waste services to its citizens. All utilities are billed under one billing which is sent out by the 10th of the month and all payments are due by the 20th of the month.

Bills not paid by the 20th, are subject to a late fee. Bills not paid by the last day of the month, are subject to disconnection. A reconnect fee will be charged when service is reconnected.

Electric Service

The electric department is responsible for reading electric meters and reporting usage to the billing department. They are also responsible for repairing electric lines and installing new electric lines across the City. Citizens must make their meters accessible to the reader. Meters should be in clear view and free of brush, debris and animals. It is unlawful to tamper with electric meters in anyway or to share electric service with other households. Every household must have their own meter. Violators will be prosecuted. Security lights are available for a monthly fee from the electric dept. Contact the utility office to schedule installation.

Water/Wastewater Service

The water/wastewater department is responsible for all water and wastewater issues. City water is regulated by state regulatory agencies and mandatory

guidelines are followed to assure high standards. The City uses surface water from Inks Lake. <u>After hours</u> number: 830-798-4776

Solid Waste

The City of Burnet has contracted with Al Clawson Disposal, Inc. to provide garbage and recycling services to citizens of Burnet. Household garbage is collected once weekly. Call the City of Burnet or refer to the Route Map on the City of Burnet website, to determine which day your location is collected. Prohibited items include batteries, tires, hazardous materials/liquids and construction debris. Appliances with Freon will be picked up from the curb **ONLY** if properly tagged by a certified technician to be Freon free. Standard residential service includes a 95 gallon cart for recycling and a 95 gallon cart for trash per household. Recycling is on your trash day, every other week. Only the trash/recycling placed in the carts will be picked up, unless it is the first full week of the month, which is bulky waste pickup. Small dead animals can be disposed of by placing them into 2 heavy plastic bags and putting them into your trash receptacle for pickup by the solid waste provider.



Municipal Court

The Burnet Municipal Court provides assistance to defendants charged with Class C misdemeanors. Citizens who have received citations from the Burnet Police Department, Burnet Code Enforcement, Burnet Animal

Control and/or other City enforcement entities, will have their cases heard at the Burnet Municipal Court. The Court Offices are located at the City of Burnet Municipal Offices, 1001 Buchanan Dr. Suite 4, in Burnet. The court offices are open from 8am - 5pm,

Monday thru Friday, except during official Federal holidays. The Clerk's office maintains an automated voice message system that provides the answers to most questions including court times and location. Pre-trials and trials are held at the City Council Chambers located at The Burnet Airport, 2302 S Water (S HWY 281). Call (512) 756-2822 to activate the Voice Mail System. cityofburnet.com

Fire/EMS



The Burnet Fire Department, located at 2002 South Water

Street. Serving in dual roles as both fire fighters and emergency medical technicians, the men and women of Burnet Fire Department are responsible for providing both fire suppression and emergency medical services. For more information and non-emergency issues, call (512)756-2662.

Police Department



The Burnet Police Department is responsible for a coverage area through the City's Extra Territorial Jurisdiction (one mile outside the current City Limit, ETJ) The administrative facility for police

operations is located at 105 S. Rhomberg. While the Police Department provides 24-hour service, the station does not provide 24-hour lobby service. The lobby is open from 8-5 p.m. Monday - Friday, except during the lunch hour. Contact the Burnet Police Department for non-emergency issues by calling (512) 756-6404.

Animal Control

The City of Burnet Code of Ordinances regulates the control of animals within the City of Burnet. Please call 911 in case of an emergency involving a problem animal. You may contact the Animal Control Officer at (512)756-6404 in cause of:

- ♦ Abused animals
- Neglected animals
- Unwanted animals
- Potentially dangerous animals

Animals are housed at the Christ-Yoder Animal Shelter & Adoption Center which is operated by the Hill Country Humane Society/SPCA in Buchanan Dam. In the event your animal is picked up by the Animal Control Officer, you may contact the shelter at (512)793-5463. Current shelter fees will be charged for the housing of your animal. The shelter is located at 9150 Hwy 1431 W in Buchanan Dam. Animals will be held for a maximum of five days.
